14:30 – 15:30	Responsible Fire Safety Management – Part Two (What we all need to know but are sometimes afraid to ask). The Building Control (Amendment) Regulations 2014 (BCAR) brought about a culture shift in Irish construction & challenged the knowledge and competence of all concerned. The 2018 Task Force Report seeks to extend improved standards into the build environment stating that Fire Safety is generally seen as a function of 4 aspects, Passive Fire Safety, Active Fire Safety, Management & Behaviour. BCAR challenged all involved to deliver higher standards in fire safety design & construction. Recent government publications present a similar challenge for those engaged in fire safety management. • Code of Practice for Fire Safety Assessment of Premises & Buildings (January 2022) • Draft Fire Safety Guide for Building Owners & Operators (Guide for persons having control under Section 18(2) of the Fire Services Acts 1981 and 2003. In November 2021 IFE hosted a Fire Safety Forum & Workshop with presentations explaining and providing direction on legislative compliance, regulatory & industry guidance. The workshop session enabled attendee participation & discussion on the subjects raised. Our 2022 workshop will follow similar format with informative presentations followed by ample time for discussion.
